

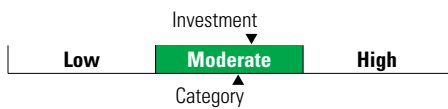

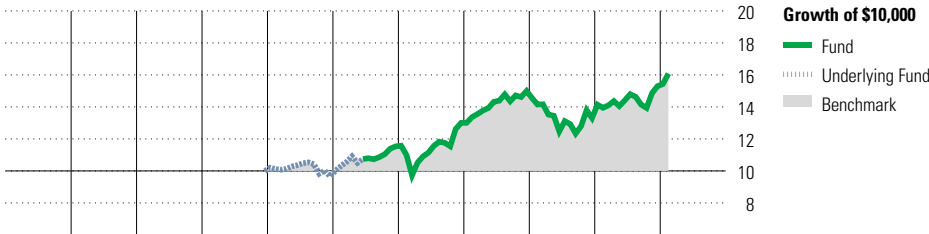
## Investment Strategy

Over time, the portfolio is rebalanced to reflect a decreasing tolerance for portfolio volatility.

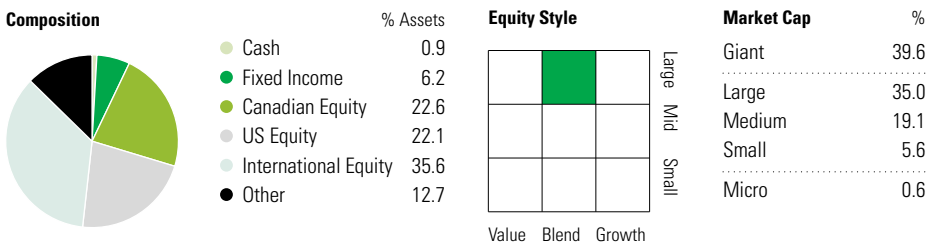
